Important Information:

1. Only online registration will be done as per the schedule.
2. Only online payment will be accepted:
 - a. As a non-refundable registration fee of Rs. 2000/- + Bank Transaction Charges common for both Govt. & Private Medical/Dental colleges/institutes/State Universities (1st & 2nd Round)
 - b. Security fee (Before Choice filling) of Rs 30,000/- + Bank Transaction Charges for Govt. Medical/Dental colleges/institutes/ State Universities.
 - c. Security fee (Before Choice filling) of Rs 2,00,000/- + Bank Transaction Charges for Private Medical colleges/institutes/ State Universities.
 - d. Security fee (Before Choice filling) of Rs 1,50,000/- + Bank Transaction Charges for Private Dental colleges/institutes/ State Universities.
3. Registration will not be completed till online payment has been made.
4. Online registration does not ensure seat allocation.

Use the same email ID & mobile number as used for AINEET PG 2019 registration and keep it active till admission.

ELIGIBILITY FOR ADMISSION:

1. Candidates who have passed MBBS/BDS course from the State Govt. Medical Colleges/ Institutes/Universities and recognized Private Medical/ Dental Colleges/ Universities of U.P. are eligible for admission in State Quota Seats in Govt. Medical Colleges/Institutes/Universities of UP through NEET-UP PG-2019/NEET-MDS-2019 Counseling and also eligible for admission in Private Medical/ Dental Colleges/ Universities of U.P
2. The Candidates who are domiciled in state of Uttar Pradesh and who have obtained admission under All India Quota/AIIMS/Central Government Institutions for MBBS course in the medical college/Institution situated outside Uttar Pradesh State and who have obtained the degree from a University situated outside of Uttar Pradesh State will also be eligible for selection process of NEET PG- 2019. Such candidates should submit (i) certificate from the Principal/ Dean of respective Medical College stating that the candidate was admitted under All India Quota/AIIMS/Central Government Institutions for MBBS Course and (ii) Candidate's Domicile certificate of Uttar Pradesh state by Virtue of residence issued by competent authority.
3. Candidates who have completed one year of Compulsory Rotatory Internship likely to complete on or before by 31st March 2019 and has qualified NEET-PG 2019/ NEET MDS 2019.
4. A candidate who has already taken admission on the basis of earlier U.P.P.G.M.E.E/A.I.P.G.M.E.E. is not eligible for the seats of Govt. Medical Colleges/State Universities until he/she completes and passes the course where he/she is presently admitted. However, such a candidate shall be eligible if he/she has resigned from the said course before NEET PG 2019 notification dt. 23.10.2018, his/her resignation has been accepted by the competent authority of the Medical/Dental college or the Vice Chancellor of state universities and he/she has refunded the salary/stipend received by him/her during the said course along with the fulfillment of the terms and condition laid down in the format of the Bond of Rs 5 Lacs at the time of admission.
5. All such candidates who have passed MBBS/BDS from outside of Uttar Pradesh but not domicile of Uttar Pradesh are eligible for admissions only in private Medical/Dental colleges/Institutes, Universities.
6. Only those NEET qualified and online registered PMHS candidates, who have been given NOC under the policy framed by Medical & Health department, U.P. and whose names list provided by DGHS UP are included in the state merit list prepared after giving due weightage as per norms will be eligible for the NEET PG 2019 U.P counseling.

APPLYING:

Step-1: Online Registration

Candidates can apply online by visiting the website <https://upneet.gov.in>

1. For registration candidate will use his/her NEET PG- 2019 roll no. and email ID (that was used for registration in NEET PG- 2019) and follow instructions on screen.
2. Thereafter the candidate's NEET PG- 2019 registration details will be displayed.
3. The candidate will make an online payment of Rs. 2,000/- (Rs. Two Thousand Only) after which SMS will be sent to his/her registered mobile no (that was used for NEET PG-2019 registration) confirming successful registration. The passwords you create at the time of registration, **kindly note this password for choice filling.**
4. After successful payment candidate will get Registration no. on his/her registered mobile number.
5. **Payment Mode- Debit Card, Credit Card, Net Banking & UPI.**

Step-2: Merit Declaration

1. For Inter-se rank in State merit list reference shall be NEET PG -2019 ranking.
2. State merit list will be prepared as per the provisions of **Order No. 358/71-4-2019-15/2018 TC dated 09 March 2019.** (Displayed on website)

Step-3: Online Security Money Payment

1. Only those candidates are eligible for choice filling who shall make successful online payment of Rs. 30,000/- (Rs. Thirty Thousand Only) for Government seats & Rs. 2,00,000/- (Rs. Two Lakh Only) for Private Medical Colleges seats and Rs. 1,50,000/- (Rs. One Lakh fifty thousand Only) for Private Dental Colleges seats as security money.
2. After declaring the state merit and paying of security money, online seat choice filling option will be available as per the schedule notified earlier.
3. Candidate would be able to take a print out of his/her online payment receipt.
4. **Payment Mode- Credit Card, NEFT & Net Banking**

Step-4: Online Choice filling

1. Visit website ***https://upneet.gov.in***
2. Click on choice filling.
3. Choice Filling Procedure:
 - a. Login for choice filing by using your NEET PG - 2019 roll number and password created at the time of registration.
 - b. Choice filing can be done on several sessions but remember to save and continue otherwise you'll lose your work.
 - c. **Choice filing will not be complete till you finally submit and lock.** No changes will be possible after locking the choice.
4. After last date of choice filing is over, seat allotment list will be declared online.

Step-5: Seat Allotment

1. Login to website. Your seat allotment status will be displayed.
2. (a) **If you allotted Seat in First Round:**
 - i. Join the college, you'll remain eligible for second counseling and you can fill the choices for second round of counseling. **If you allotted any other seat or same seat again in second round of counseling, then previous allotment will be automatically cancelled and it would be mandatory to join the upgraded seat. If you not join in concern medical college/ nodal center your allotment will be cancelled.**
 - ii. If you do not join or resign after joining even then you're eligible for second round of counseling but will forfeit your security deposit. **If you want to participate in second round of counseling, deposit security money again.**
 - iii. The seat allotment will be done by the online process on merit cum option basis.
- (b) **If you allotted seat in Second Round:**

If you do not join or resign after joining, then you're not eligible for MopUp Round and also forfeit your security deposit.

Person with Disability (PWD) category candidates are essentially required to be physically present before medical board constituted by the Government of India as per notification date 15/02/19. List of Centres who will issue Disability Certificates as per 21 Benchmark Disabilities given under RPWD Act-2106 (Annexure II) and as per MCI Amendment notification 04/02/19.

3. Candidate eligible for the reserved category will be given admission as per rules of the state government, applicable on the date of counseling.
4. OBC candidates covered by the provisions of the creamy layer will not be entitled for the benefits of OBC category.
5. Candidates who fail to produce required original documents at the time of admission or if any concealment or falsification of facts comes in to the light at the time of admission or thereafter during the course of study then candidature will be cancelled. Legal action would be taken against such candidates.
6. Candidates will be checked for their identity at the time of admission. If it does not match it will be counted as unfair means and their candidature will be cancelled. Additional legal action would be taken against such candidates.
7. If candidate does not participate in online counseling or does not join the allotted seat by the due date he/she shall forfeit any right of admission on the basis of said counseling/allotment.
8. **The option once exercised by the candidate in the online counseling cannot be altered under any circumstances.**
9. No request for re-allotment of seats already allotted in the first and second round will be entertained.
10. **After the choice filling, locking is mandatory if you do not lock the choices then you will not be consider for the allotment process.**

MOP-UP ROUND:

मॉपअप राउण्ड हेतु पृथक से पंजीकरण शुल्क (रु0 1000/-) जमा करते हुए पंजीकरण कराना अनिवार्य होगा।

- a. If seats are left un-allotted at the end of the second round of online counseling, then a "mop-up" round of allotment will be organized at a notified date, after due publicity. The purpose of the mop up round of seat allotment will be to ensure that there is no loss of PG seats in the current academic year. Seats will be offered to eligible candidates strictly according to their position in the NEET PG 2019/NEET UPPG 2019 state merit list as applicable.
- b. The terms and conditions for participation by candidates in this mop up round will be as follows:-
 1. Candidates who are allotted /admitted but not joined/resigned any seat in UP will not be eligible for participation.
 2. Any candidate who has taken admission in any PG course in any medical college in India also will not be eligible for participation.
 3. Candidates will have to produce certificates in original as well as two self attested photocopies of all the documents.

ADMISSION:

1. Admission of the candidate to various P.G. Degree/ Diploma course will be given by the Principal/Dean/ Director of the respective Medical Colleges/ Institutes/Universities or Medical/Dental faculty of K.G. Medical University, Lucknow as the case may be as per the NEET UPPG 2019 State merit.
2. A candidate who has been allotted a P.G. Degree/Diploma course in a particular Government Medical/Dental College shall have to complete all the admission formalities including depositing the prescribed fee , by the date notified for this purpose to the respective Principal/Dean/Director of Medical College/ Institute or K.G. Medical University, Lucknow as the case may be. Those who fail to do so will lose their claim for admission.
3. A candidate who has been allotted a P.G. Degree/Diploma course in a particular Private Medical/Dental College shall have to complete all the admission formalities including depositing the prescribed fee , by the date notified for this purpose at Nodal Center. **See the list of Nodal Centers as annexure-1.** Those who fail to do so will lose their claim for admission.
4. Admission shall be given only after the candidate produces in original as well as oneself attested photocopy each of the following documents at the office of the Principal/Dean/Director of the allotted Medical College /Institute/University concerned or the Registrar, KG Medical University, Lucknow, as the case may be
 - a. High School Certificate as proof of date of birth.
 - b. Mark sheets of all professional examinations.
 - c. MBBS/BDS passing out certificate or degree.
 - d. Compulsory Rotatory Internship completion certificate.
 - e. Permanent Registration Certificate (U.P. State/MCI/DCI).
 - f. Employers relieving certificate, if employed.
 - g. S.C./S.T./O.B.C./Person with Disability certificate, if applicable.
 - h. Copy of Allotment letter (as downloaded)
 - i. Admit Card of NEET PG 2019.
 - j. Online registration proof.
 - k. Print out of candidate's State merit placement.
5. It will be mandatory for candidate to furnish a bond on Rs. 100/- stamp paper , at the time of admission in the concerned **Government Colleges**. The bond is to ensure that in case the student leaves the seat after the 2nd counseling, or at any time during the course of study, then the candidate will deposit an amount of Rs 5,00,000/- (Rupees Five Lakh)
6. It will be mandatory for candidate to furnish a bond on Rs. 100/- stamp paper, at the time of admission in the concerned **Private Colleges**. The bond is to ensure that in case the student leaves the seat after the 2nd counseling or at any time during the course of study, then the candidate will deposit total amount of tuition fee of the course.
7. After the admission process is completed the candidate will submit in writing his/her joining report to the Head of the Department concerned.
