A. PROJECT INFORMATION BRIEF

1. BACKGROUND

Department of Medical Education, Government of Uttar Pradesh (the “**Authority**”) is committed to improve the health scenario in the state of Uttar Pradesh and is engaged in the development of health infrastructure and provisioning of effective healthcare services across the state. The Authority seeks to invite inputs/expressions from interested private party(ies) (hereinafter for the purposes of this EOI is referred as “**Service Providers**” or “**Interested Party**”) for setting up with previous experience in the relevant field of setting up and operationalizing in-house Pharmacies and may on its discretion decide to carry out the bidding process for the selection of such private Service Providers.

This EOI is issued for seeking response from the eligible and competent private parties to set up retail chemist outlets (pharmacy) across 6 (six) 200 to 250 bedded Pradhan Mantri Swasthya Suraksha Yojana (“PMSSY”) super-specialty blocks in select Government Medical Colleges of Uttar Pradesh (Gorakhpur, Kanpur, Prayagraj, Meerut, Agra, Jhansi) for ensuring uninterrupted and just-in-time supply of medicines, implants, surgical, consumables, chemicals and other medical supplies against the indent as and when raised by the hospital through its designated official(s) as required for the treatment and care of the in-house (OPD and IPD) patients. The proposed 6 Districts are mentioned in the **Appendix-II** of this document.

As a part of this Project, the indicative scope of work is summarized below:

Role of the Service Provider:

- (i) the Service Provider shall be required to Set-up and operationalize in-house Pharmacies across 6 (six) PMSSY blocks in select Government Medical Colleges (Government Medical College, Gorakhpur, Government Medical College, Kanpur, Government Medical College, Prayagraj, Government Medical College, Meerut, Government Medical College, Agra, and Government Medical College, Jhansi) of Uttar Pradesh including the fitting, furnishing, manpower & the supply of medicines, implants, surgicals and consumables drugs (these have to be supplied at discounted MRP rates) to the patients as per the Essential Drug List and the Standard Drug List (SDL & EDL).
- (ii) The Pharmacy would be required to provide to the patients all the materials as required on payment basis. In case of life-saving drugs, the same should be provided within 1 (one) hour and all other drugs within 12 (twelve) hours from the time of placing of order by the patient. It is mandatory to ensure there is no refusal of treatment by the hospital due to non-availability of medicines, implants, surgical consumables, etc.
- (iii) The indicative list of items under different category to be stored and dispensed by

the In-house Pharmacy is enclosed under **Appendix IV**. The detailed actionable list of medicines, implants, surgical, sutures, consumables, chemicals, reagents, and other supplies to be stored and dispensed by the In-house Pharmacy to be set up by the Service Provider across 6 (six) PMSSY blocks would be provided in the relevant tender document that may be issued pursuant to this EOI.

- (iv) the Service Provider will assure that the drugs dispensed are of standard quality as per Drug & Cosmetic Act 1940.
- (v) Indicative models for commercial arrangement with Government:
 - a. Pay fixed annual amount of INR ***** p.a. to the Government as fixed annual revenue OR
 - b. Pay minimum premium above C&F rates to the Government. The difference of amount between MRP & C&F rates of each amount shall be shared as patient discount, government's revenue share and bidder's profit.
 - c. Or any other suggestions/ models by the bidders.

Role of the Government:

- (i) To provide built space of required size and dimension within the hospital premises to run the Pharmacy (Chemist) outlet and storage of material.
- (ii) Provide un-interrupted electricity and water supply with sub-meters for paying the electricity bills. For avoidance of doubt, it is clarified that the private partner shall be responsible for the payment of all utility bills/charges.

B. INSTRUCTIONS FOR SUBMISSION

1. PURPOSE

- 1.1 The purpose of this EOI is to gather initial information for the proposed Project and identify potential Interested Party(s) to gauge the market interest for the Project. Based on the inputs the Authority may decide to structure the Project and take it to the market seeking participation from private sector. The EOI document may be downloaded from the *****website (*****).
- 1.2 This EOI is not and cannot be construed as an invitation to offer or creating any right whatsoever in favor of any participating entity, who chooses to respond to this EOI. The Authority may, in its absolute discretion but without being under any obligation to do so, update, amend or supplement the information, assessment or assumptions contained in this EOI. The issue of this EOI does not imply that the Authority is bound to undertake the bidding process and/or select and short-list pre-qualified Interested Parties, pursuant to this EOI, for qualification and/or bid stage or to appoint the selected Bidder, as the case may be, for the Project and the Authority reserves the right to not abide by the information furnished by the Interested Party hereunder without assigning any reasons whatsoever.

The Authority invites responses to this EOI from any sole legal entity registered under relevant laws in force in India, and fulfilling the following conditions:

- i. Consortium/Joint Ventures of entities are not permitted to submit their responses under this EOI.
- ii. Interested Party should not have any insolvency/liquidation proceeding is admitted/pending before the Competent authority under Insolvency and Bankruptcy Board, 2016 and as amended.
- iii. Interested Party should not be barred/blacklisted from participating in any public procurement in India &/or State of Uttar Pradesh, and such order should not be subsisting as on EOI Due Date.

iv. Interested Party fulfills the following indicative Technical and Financial criteria's:

- a) He should have more than 05 (five) years' experience in Health Sector.
- b) He should have a minimum average annual turnover of Rs. 25/- Crores (Rupees twenty-five Crores) in last three financial years starting from 2019-20, 2020-21 & 2021-22.
- c) He should have a minimum of 15 (fifteen) pharmacy outlets/warehouses presently operational in India and out of these 15 (fifteen) stores, at least two should be in the Hospital as hospital base pharmacy.

3. SUBMISSION OF EOI

3.1. Interested Parties are requested to submit their responses to this EOI in the form and manner prescribed in Clauses 5 & 6 of this EOI. The response to this EOI to be submitted by the Interested Parties shall include the following:

The above documents shall be a single file, with each page initialed by the authorized signatory of the Interested Party.

4. BIDDING PROCESS

4.1. In furtherance of this EOI, if the Department of Medical Education, Government of Uttar Pradesh (the "**Authority**") decides to issue an Invitation to offer/tender document, the bidding process that is adopted may be on the following lines:

The Bidding Process would be based on single stage two envelope system using the QCBS mode of selection process, wherein the Technical Bid will have 60% weightage and Financial Bid will have 40% weightage. Further, the bidder who scores at least 60 marks pursuant to its Technical Bid evaluation will only be eligible for opening an evaluation of its Financial Bid.

The Bid parameter based on which the Financial Bid could be decided to be invited can be the maximum discount (percentage) offered on the MRP of all items as per Appendix IV or other appendix that may be appended to tender document that may be issued. It is hereby clarified that, the Interested Parties who submit their responses to this EOI do not get any exclusive right to participate in the bidding process, if undertaken for the Project.
