Important instructions regarding admission process for allotted candidates on MD/MS/Diploma seats by UP

NEET PG-2022

- 1- Admission process for candidates allotted in Govt. Medical Colleges/Universities/Institutes, will be completed by Principal/Dean/Director of the concerned Medical Colleges/Universities /Institutes.
- 2- The Admission process for candidates allotted in Private Medical Colleges, will be completed at Nodal Centers nominated by Govt. List of Nodal Centers has been Attached/Uploaded.
- 3- All candidates will have to bring their original passing certificates & other relevant documents along with and self-attested photocopy of all documents at the time of admission.
- 4- All candidates allotted in Private Medical Colleges, will have to bring a CTS Bank draft for tuition fee decided by Govt. in favor of, Director General Medical Education & Training, U.P. payable at Lucknow. Candidates will have to deposit original documents after verification at nodal centers.
- 5- If Private Medical Colleges allows admissions at lower tuition fee (than decided by Govt.), bank draft of lower tuition fee can be deposited at nodal center to complete the admission process.
- 6- List of tuition fee decided by Govt. for Private Medical Colleges & Minority institutes in available at website www.dgme.up.gov.in & upneet.gov.in
- 7- Candidates who got admitted in state Govt. seats after allotment from AIQ, and if they are allotted state Quota seats, they can take admission in state quota allotted seats only if they produce NOC from allotted college in AIQ, Such candidate will have to submit all documents in original before 2nd round of counseling, otherwise, their seats will be considered vacant & will be included in 2nd round of counseling and only candidate will be responsible for this.
- 8- Medical board have been formed at the level of Medical College/University/Nodal Center for conducting Medical examination of all allotted candidates. Medical is compulsory for all allotted candidate.
- 9- Candidates from PMHS cadre will have to complete their admission process by presenting NOC issued by Director General Medical Health. It will be compulsory for PMHS candidates to submit relieving certificate from competent authority before 2nd round of counseling.
- 10- Economically weaker section (EWS) of UP and OBC candidates will have to submit their EWS & OBC certificate respectively at the time of admission. Certificates issued on after 1st April, 2022 will be considered valid. If instructions are not followed, admission will be cancelled & candidate will be responsible for this action.
- 11- All Candidate/Guardians will have to follow Covid Protocol Strictly during admission process after allotment from U.P. NEET PG-2022 counseling.
